



**EXHIBITOR DESIGNATED CONTRACTOR**  
**INSURANCE REQUIREMENTS**  
**(Deadline March 24, 2008)**

All companies providing a service to exhibitors must be licensed and insured prior to entering the premises of the San Diego Convention Center. Exhibitors intending to use an Exhibitor Designated Contractor for the installation and dismantling, photography, floral, A/V etc., of their exhibit must provide Show Management with an **original and valid certificate of insurance by March 24, 2008**, providing coverage from 12:01 a.m. on May 8, 2008 to 11:59 a.m. on May 14, 2008. All Exhibitor Designated Contractors shall at their own expense secure and maintain the Insurance listed below. All such insurance shall be primary of any other valid and collectible insurance of Licensee and/or Operator and shall be written on an occurrence basis. Claims made policies are not acceptable and do not constitute compliance with Licensee's obligations under this paragraph.

**Minimum Insurance Coverage must include:**

**1. Commercial General Liability** policy with coverage as broad as ISO CG0001 in the occurrence form providing coverage against claims for bodily injury or death and property damage occurring in or upon or resulting from exhibitors use of the facility and endorsed to include non-owned and hired automobile liability coverage (if exhibitor/exhibitor designated contractor does not maintain owned automobile liability coverage.) Such insurance shall be primary and not require contribution from any of the additional insureds other insurance coverages, and shall afford immediate defence and indemnification, as named additional insureds, to the AATS, city of San Diego, San Diego Unified Port District,, to the limit of not less than ONE MILLION DOLLARS (\$1,000,000)

**2. Worker's Compensation Insurance** as required by law.

**3. Automobile Liability:** For owned vehicles other than private passenger automobiles, Commercial Automobile Liability coverage with limits not less than \$1,000,000 each occurrence combined single limit for bodily injury or death and property damage.

**The Commercial General Liability policy described shall include the following additional insured endorsement language:**  
San Diego Convention Center Corporation, Inc, City Of San Diego, San Diego Unified Port District, The Aats And The Members, Officers, Directors, Agents And Employees Of Each Of These Entities Are Named As Additional Insureds And Are Provided The Same Coverage As The Named Insured, Including The Cost Of Defense, Against Claims For Bodily Injury, Death, Or Property Damage Occurring In Or Upon, Or Resulting From The Insureds

Use Or Occupancy Of The San Diego Convention Center and/or the San Diego concourse.

**The cancellation clause for the above policies and certificates shall read as follows:**

Should any of the above described policies be cancelled before the expiration date thereof, the issuing company will mail 30 days written notice to the certificate holder.

The parties agree and Exhibitor/Exhibitor Designated Contractor understands that the specified coverage or limits of insurance in no way limit the liability of the Exhibitor/ Exhibitor Designated Contractor. The Exhibitor/ Exhibitor Designated Contractor shall maintain, with respect to each such policy or agreement, evidence of such insurance coverage and endorsements required by this agreement.

FAILURE TO PROVIDE AN **ORIGINAL AND VALID CERTIFICATE OF INSURANCE** BY  
March 24, 2008 WILL RESULT IN THE EXHIBITOR DESIGNATED CONTRACTOR  
NOT BEING ALLOWED TO PERFORM WORK IN THE EXHIBIT HALL.
